ORDER:-

Whereas, Sri.A.Satya Murthy, Deputy Director of Town Planning, working on deputation as Planning Officer, Amalapuram Urban Development Authority, Amalapuram vide application read (3) above has informed that, he would like to retire voluntarily due to some health issues and requested to approve his Voluntary Retirement on Medical grounds.

And whereas, as verified from records, said Sri.A.Satya Murthy, DDTP/PO, AMUDA, Amalapuram initially appointed as Town Planning Town Planning Building Overseer on 28-04-1989 in Bhimavaram Municipality. Subsequently he was promoted to the post of TPS, TPO, ADTP and DDTP under AP Town Service and joined duty on **05-12-2024 in the post of DDTP**. Thus he has put in more-than 35 years of service as on the date.

And whereas, as per records, there is no disciplinary case pending against said Sri.A.Satya Murthy, DDTP/PO, AMUDA, Amalapuram as on the date.

And whereas, the requisition made by Sri.A.Satya Murthy, DDTP/PO, AMUDA, Amalapuram has been examined with reference to the provisions under Rule 43 (1) & (4) of APRP Rules, 1980 and following orders issued :

Now, therefore, in exercise of the powers conferred on the Director of Town and Country Planning, A.P., Amaravati vide G.Os read (1) and (2) above and as per the provisions under Rule 43 (1) & (4) of AP Revised Pension Rules, 1980, Sri.A.Satya Murthy, DDTP/PO, AMUDA, Amalapuram who is a member of the A.P. Town Planning Service, is hereby permitted to retire from service on voluntary basis **w.e.f. 30-06-2026 AN** on medical grounds.

The individual is informed that he is allowed to retire from service on voluntary basis, subject to condition, that, if any disciplinary proceedings that may arise prior to his retirement and without prejudice to the right of the Government / Department, will continue to be the disciplinary proceedings or judicial proceedings, during his service or after retirement, in terms of G.O.Ms.No.171, Finance & Planning Department, dt.01-07-1974 read with F.R 56 (10) (2).
