ORDER:

In the reference 3rd read above, the Director of Public Health & Family Welfare, Andhra Pradesh, Vijayawada has submitted a proposal requesting to enhance the age of superannuation of Dr.R.Malini, Civil Surgeon (General Line), Principal, RTC (Male), Nallapadu, Guntur District, from 62 years to 63 years in terms of G.O.Ms.No.86, HM&FW (A) Department, dated 31.05.2017.

2. Government, after careful examination of the matter, hereby accord permission for enhancement of the age of superannuation of Dr.R.Malini, Civil Surgeon (General Line), Principal, RTC (Male), Nallapadu, Guntur District, from 62 years to 63 years in terms of G.O.Ms.No.86, HM&FW (A) Department, dated. 31.05.2017. Accordingly, she shall retire from Government service on attaining the age of 63 years, i.e., on 30.06.2027.

3. Consequently, the retirement notification issued in G.O.Ms.No.168, HM&FW (B1) Department, dated.08.12.2025 shall stand modified to the extent of omitting the name of Dr. R.Malini, Civil Surgeon (General Line), Principal, RTC (Male), Nallapadu, Guntur District.
