In the reference ^{3rd} cited, Departmental Action under APCS (CCA) Rules, 1991 had been initiated against Dr.B.V.Prasad, CSS, Area Hospital, Guntakal, on allegation of his non availability in Area Hospital, causing suffering to patients in rural/urban areas.

2. In the reference 12th cited, DSH, AP, has informed that Dr.B.V.Prasad, CSS, was on unauthorized absence from duties w.e.f., 23-02-2009 to till date and the said doctor address was not found to serve the show cause notice and the WSD is not received from the CO.

3. After careful examination of the matter, the Government have decided to initiate disciplinary action in terms of the orders issued vide G.Os. 13th & 14th cited read with Rule 18 of FR, on Dr.B.V.Prasad, CSS, Area Hospital, Guntakal, and his services shall be treated as deemed to be resigned w.e.f 23-02-2009

4. Dr.B.V.Prasad, CSS, Area Hospital, Guntakal, is directed to show cause within 15 days from the date of receipt of the Memo as to why a major punishment should not be imposed against him under the provisions stipulated in G.Os. 13th & 14th cited for the unauthorized absence from official duties continuously w.e.f. 23-02-2009.

5. The DSH, AP, is requested to serve the memo to the individual and furnish served copy to Government immediately.
