And whereas, a special meeting of the Mandal Parishad Territorial Constituency Members of the Mandal Praja Parishad, Jupadu Bungalow, Nandyal District, for the purpose of considering the above said ‘No Confidence Motion’ was held on 02.05.2026 in the premises of the Mandal Praja Parishad, Jupadu Bungalow, Nandyal District.

And whereas, when the said Motion was put to vote, it was supported by (07) Mandal Parishad Territorial Constituency Members present, out of the total number of (09) Mandal Parishad Territorial Constituency Members of the Mandal Praja Parishad, Jupadu Bunglow, Nandyal District and the Motion was passed with the requisite majority.

Now, therefore, in exercise of the powers conferred by sub-section (1) of Section 245 of the Andhra Pradesh Panchayat Raj Act, 1994 read with G.O.Ms.No.200, Panchayat Raj & Rural Development (Mdl.I) Department, Dated:28.04.1998, the Government, hereby, remove Sri T.Krishna Reddy, Vice President-I, Mandal Praja Parishad, Jupadu Bunglow, Nandyal District, with immediate effect.
