NOTIFICATION-I

In exercise of the powers conferred by clause (a) of Sub section (1) of Section 9 of the Indian Stamp Act 1899, the Governor of Andhra Pradesh hereby remit the Stamp Duty in full chargeable on total document value for transfer of land measuring to an extent of Acs 49.66 Cts situated in survey Nos. 59, 60 located at Uddandarayanipalem villages and survey Nos. 53, 54, 55, 58, 59, 60, 61, 63, 64, 65, 66, 67, 68, 74, 75 located at Lingayapalem villages of Guntur District, Andhra Pradesh from AP Capital Region Development Authority (APCRDA) in favour of ITE&C Department, GoAP for establishment of Amaravati Quantum Valley.

NOTIFICATION-II

In exercise of the powers conferred by Section 78 of the Registration Act, 1908 (Act XVI of 1908), the Governor of Andhra Pradesh hereby makes the following amendment to the Book 1 of CARD of "Table of fee" issued in G.O.Ms.No.463, Revenue (Regn.I) Department, dated:17.08.2013 and subsequently amended from time to time.

AMENDMENT

In the said "Table of Fees" after category 6(b)(ii), the following shall be added as 6(b)(iii) namely:

6(b)(iii): No registration fee shall be levied on documents value for transfer of land measuring to an extent of Acs 49.66 Cts situated in Survey Nos. 59, 60 located at Uddandarayanipalem village and Survey Nos. 53, 54, 55, 58, 59, 60, 61, 63-68, 74, 75 located at Lingayapalem villages of Guntur District, Andhra Pradesh from AP Capital Region Development Authority (APCRDA) in favour of ITE&C Department, GoAP for establishment of Amaravati Quantum Valley.
