EXEMPTION OF STAMP DUTY, REGISTRATION FEE, USER CHARGES UNDER SECTION 9(1)(a) OF THE INDIAN STAMP ACT, 1899 AND REGISTRATION FEE UNDER SECTION 78 OF THE AP REGISTRATION ACT, 1908 FOR CORRECTION OF PLOT CODES AND PLOT BOUNDARIES IN REGISTERED DOCUMENTS ARISING DUE TO CHANGE IN NAMING CONVENTION OF PLOT CODES INTRODUCED BY ANDHRA PRADESH CAPITAL REGION DEVELOPMENT AUTHORITY (APCRDA) WHERE OWNERSHIP HAS ALREADY BEEN TRANSFERRED AND UNDERGONE ONE OR MULTIPLE REGISTRATIONS - PERMISSION FOR EXECUTION OF RECTIFICATION DEEDS BY THE COMPETENT AUTHORITIES OF APCRDA.

NOTIFICATION-I

In exercise of the powers conferred by clause (a) of Sub section (1) of Section 9 of the Indian Stamp Act 1899, the Governor of Andhra Pradesh hereby remit the Stamp Duty, Registration fee, User charges for correction of plot codes and plot boundaries in registered documents arising due to change in naming convention of plot codes introduced by Andhra Pradesh Capital Region Development Authority (APCRDA) where ownership has already been transferred and undergone one or multiple registrations to permit the execution of such rectification deeds by Competent Authorities of APCRDA.

NOTIFICATION-II

In exercise of the powers conferred by Section 78 of the Registration Act, 1908 (Act XVI of 1908), the Governor of Andhra Pradesh hereby makes the following amendment to the Book 1 of CARD of "Table of fee" issued in G.O.Ms.No.463, Revenue (Regn.I) Department, dated:17.08.2013 and subsequently amended from time to time.

AMENDMENT

In the said "Table of Fees" after category 6(b)(iii), the following shall be added as 6(b)(iv)) namely:

6(b)(iv): No registration fee shall be levied on documents value for correction of plot codes and plot boundaries in registered documents arising due to change in naming convention of plot codes introduced by Andhra Pradesh Capital Region Development Authority (APCRDA) where ownership has already been transferred and undergone one or multiple registrations to permit the execution of such rectification deeds by Competent Authorities of APCRDA.
