PROPOSAL FOR ORGANISATION OF CLASSES OF POSTS IN CIVIL SERVICES AND CIVIL POSTS UNDER THE STATE INTO DIFFERENT LOCAL CADRES FOR DIFFERENT PARTS OF THE STATE UNDER THE PANCHAYAT RAJ - PARAGRAPH 3(7) OF THE ANDHRA PRADESH PUBLIC EMPLOYMENT (ORGANISATION OF LOCAL CADRES AND REGULATION OF DIRECT RECRUITMENT) ORDER, 2025 -APPROVED.

NOTIFICATION

In exercise of the powers conferred under sub-para (7) of paragraph 3 of the Andhra Pradesh Public Employment (Organisation of Local Cadres and Regulation of Direct Recruitment) Order, 2025, the State Government declares that it would not be practicable/expedient to organize the category of posts as local cadres specified in the table below and accordingly declare to this effect under the said paragraph in respect of the Non-gazetted categories of posts in Panchayat Raj Department:-

Name of the Secretariat Department: Panchayat Raj and Rural Development Department

Name of the Head of the Department: Panchayat Raj Department

Consequent to the above notification, the Government hereby order that the posts specified above shall continue to be as district cadre on administrative necessities for the purpose of unit of appointment, recruitment, discharge, seniority, promotion, transfer and other service matters as per the service rules governing the said posts. However, the extent of reservation to the local candidates in the matter of direct recruitment to the posts to be filled by direct recruitment shall be as specified in the Presidential Order, 2025.

The Department shall take necessary action to amend the relevant service rules and readjust the territorial jurisdictions, wherever required, in accordance with these orders.

The Special Chief Secretary to Government, Panchayat Raj and Rural Development Department shall take necessary immediate action in the matter accordingly.
