In exercise of the powers conferred by clause (a) of Sub section (1) of Section 9 of the Indian Stamp Act 1899, the Governor of Andhra Pradesh hereby remit the Stamp Duty, Registration fee, User charges for Relaxation / Waiver of Stamp Duty and Registration Fee for exchange of 4.68 Acres of APTA land in Sy.No.604/10 & 604/11, Peruru Village, with 5.00 Acres of TTD land in Sy.No.588/A, Tirupati RS Village.

AMENDMENT

In the said "Table of Fees" after category 6(b)(iv), the following shall be added as 6(b)(v) namely:

6(b)(iv): No registration fee shall be levied for Relaxation / Waiver of Stamp Duty and Registration Fee for exchange of 4.68 Acres of APTA land in Sy.No.604/10 & 604/11, Peruru Village, with 5.00 Acres of TTD land in Sy.No.588/A, Tirupati RS Village.
