PROPOSAL FOR ORGANISATION OF CLASSES OF POSTS IN CIVIL SERVICES AND CIVIL POSTS UNDER THE STATE INTO DIFFERENT LOCAL CADRES FOR DIFFERENT PARTS OF THE STATE UNDER THE CHIEF COMMISSIONER OF LAND ADMINISTRATION AS PER PARAGRAPH 3(7) OF THE ANDHRA PRADESH PUBLIC EMPLOYMENT (ORGANISATION OF LOCAL CADRES AND REGULATION OF DIRECT RECRUITMENT) ORDER, 2025 - APPROVED.

NOTIFICATION

In exercise of the powers conferred under sub-para (7) of paragraph 3 of the Andhra Pradesh Public Employment (Organisation of Local Cadres and Regulation of Direct Recruitment) Order, 2025, the State Government declares that it would not be practicable/expedient to organize the following categories of posts as local cadre specified in the table below and accordingly declare to this effect under the said paragraph in respect of the Non-gazetted category of posts in Chief Commissioner of Land Administration :-

Name of the Secretariat Department:- Revenue Department

Name of the Head of the Department:- Chief Commissioner of Land Administration

Consequent to the above notification, the Government hereby order that the posts specified above shall continue to be as District cadre on administrative necessities for the purpose of unit of appointment, recruitment, discharge, seniority, promotion, transfer and other service matters as per the service rules governing the said posts. The Appointing Authority for the said six posts shall be the District Collector concerned. However, the extent of reservation to the local candidates in the matter of direct recruitment to the posts to be filled by direct recruitment shall be as specified in the Presidential Order, 2025.

The Revenue Department shall take necessary action to amend the relevant service rules and readjust the territorial jurisdictions, wherever required, in accordance with these orders.

The Special Chief Secretary to Government, Revenue Department shall take necessary immediate action in the matter accordingly.
