**ORDER:**

Whereas, as per the records of this office, the date of birth of Smt N.Narayanamma, Superintendent, O/o RDDTP, Ananthapuramu is 06-08-1964 and accordingly, she has to retire from service on the A.N. of 31-08-2026 on attaining the age of superannuation of (62) years in terms of G.O read (7) above.

And whereas, a Retirement Notice has already been issued to her vide this office Memo read (8) above, as required under rules.

Now, therefore, in exercise of the powers conferred on the Director of Town and Country Planning, Government of A.P., vide orders of the Government issued in G.O's 1<sup>st</sup> to 7<sup>th</sup> and in pursuance of the orders of the Government issued from time to time in respect of retirements of the Government employees on attaining the age of superannuation vide G.Os, following orders are issued:

Smt N.Narayanamma, Superintendent, O/o RDDTP, Ananthapuramu is permitted to retire from service on 31.08.2026 A.N. on attaining the age of superannuation of (62) years, as per the existing Government orders, in force, issued in G.O. read (7) above.

The individual is informed that she is allowed to retire from service, subject to condition, that, if any disciplinary proceedings that may arise prior to his/her retirement and without prejudice to the right of the Government/ Department, shall continue to be the disciplinary proceedings or judicial proceedings, during her service or after retirement, in terms of G.O.Ms.No.171, Finance & Planning Department, dt.01-07-1974 read with F.R 56 (10) (2). Further, if she is already facing any disciplinary case(s) prior to his/her retirement which comes to the notice of the Department/Government at any later date, the provisions under Article 351-A of Pension Code, Rule.9 of A.P. Revised Pension Rules, 1980 will attract and accordingly the Government reserves the right to regulate Pensionary benefits of the employee even after his/her retirement.

Smt N.Narayanamma, Superintendent, O/o RDDTP, Ananthapuramu is hereby allowed to retire from service and consequently relieve from her duties on the A.N. of 31-08-2026.

The RDDTP, Ananthapuramu is hereby directed to take necessary action duly making internal arrangements.
