Municipal Administration & Urban Development Department – Kadapa Urban Development Authority (KDP UDA) - Exclusion of certain ULBs/Mandals/Villages in the Jurisdiction of Kadapa Urban Development Authority (KDP UDA) - Orders- Issued.

NOTIFICATION

In exercise of the powers conferred by clauses (a) and (b) of sub-section (3) of section 3 of the Andhra Pradesh Metropolitan Region and Urban Development Authorities Act, 2016 (Act No. 5 of 2016), read with sub-section (2) of the said section, and in partial modification of the notifications previously issued defining the Development Area of the Kadapa Urban Development Authority (KDP UDA), the Government of Andhra Pradesh hereby: (a) exclude there from the areas specified in Schedule-I; and (b) define the revised limits of the Development Area of KDP UDA as comprising the areas specified in Schedule-II, with effect from the date of publication of this notification in the Andhra Pradesh Gazette. This re-organisation is intended to facilitate streamlined administration, coordinated urban development, effective spatial planning and efficient management of urban and peri-urban areas within the Development Area of KDP UDA.
