Municipal Administration and Urban Development Department - Chittoor Urban Development Authority (CHUDA) – renaming of CHUDA as “Chittoor– Palamaneru – Kuppam Urban Development Authority (CPK UDA)” - Re-organisation of UDA - Inclusion and deletion of certain Mandal/Villages in the Jurisdiction of CPK UDA –Orders-issued - Notification - Orders - Issued.

NOTIFICATION

In exercise of the powers conferred by clauses (a) and (b) of sub-section (3) of section 3 of the Andhra Pradesh Metropolitan Region and Urban Development Authorities Act, 2016 (Act No. 5 of 2016), read with sub-section (2) of the said section, and in partial modification of the notifications previously issued defining the Development Area of the Chittoor Development Authority (CHUDA), the Government of Andhra Pradesh hereby: renamed the Chittoor Urban Development Authority (CHUDA) as “Chittoor– Palamaneru –Kuppam Urban Development Authority (CPKUDA)” and (a) include in the said Development Area the areas specified in Schedule-I; (b) exclude there from the areas specified in Schedule-II; and (c) define the revised limits of the Development Area of CPK UDA as comprising the areas specified in Schedule-III, with effect from the date of publication of this notification in the Andhra Pradesh Gazette. This reorganisation is intended to facilitate streamlined administration, coordinated urban development, effective spatial planning and efficient management of urban and peri-urban areas within the Development Area of CPK UDA.
