NOTIFICATION -I

In exercise of the powers conferred by sub-section (1) of section 3 of the Andhra Pradesh Metropolitan Region and Urban Development Authorities Act, 2016 (Act No.5 of 2016), the Government of Andhra Pradesh having regard to the need for the promotion of development activities relating to as a Urban Development Authority to achieve the objectives of the region witnesses tremendous growth in the domains of Industries, Imports and Exports etc. hereby specify a special Urban Development Area for the area comprised within the jurisdiction of Markapuram District consisting of (4) Urban Local Bodies (ULBs) and twenty one (21) Mandals and 507 Villages to an extent of 6037.39 Sq.Km with Head Quarters at Markapuram as specified in the Schedule appended to this notification to be a Urban Development Area for the purpose of the said Act and the said Area shall be as "Markapuram Urban Development Area (MRK UDA)".

NOTIFICATION – II

In exercise of the powers conferred by sub-section (1) and clause (ii) of sub-section (3) of section 4 of the Andhra Pradesh Metropolitan Region and Urban Development Authorities Act, 2016, the Government of Andhra Pradesh hereby constitute an Urban Development Authority for the area specified in the Notification – I above for the purpose of the said Act and the said Authority shall be called as the “Markapuram Urban Development Authority (MRK UDA)” and shall consist of the following members, namely:-
