AMENDMENT TO THE ANDHRA PRADESH SPECIAL PROTECTION FORCE
SUBORDINATE SERVICE RULES, 1995.

NOTIFICATION

In exercise of the powers conferred by section 21 of the Andhra Pradesh Special Protection Force Act, 1991 read with the proviso to article 309 of the Constitution of India and of all other powers hereunto enabling the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Special Protection Force Subordinate Service Rules, 1995 issued in G.O.Ms.No.208, Home (Police-F) Department, dt.20.08.1997 and as subsequently amended from time to time.

AMENDMENT

In the Said Rules,

in Annexure-I in the table, under the heading Class-I, for Category-I, Sub-Inspector and its corresponding entries made under Columns (2) and (3), the following shall be substituted, namely,-

Class and Category	Method of appointment	Limitation

"Class - I Category 1 Sub Inspector	(a) Direct Recruitment from Open Competition	47%
	(b) Direct Recruitment from amongst Meritorious Sports personnel	3%
	(c) Direct Recruitment from amongst NCC candidates	2%
	(d) Direct Recruitment from amongst members of Special Protection Force.	5%
	(e) Direct Recruitment from amongst Children of SPF members including retired / deceased / incapacitated members.	3%
	(f) By promotion of Assistant Sub- Inspector of Special Protection Force Class 1, Category-2.	35%
	(g) By deputation of Sub-Inspector from State or Central Police Organizations (failing which by promotion of Assistant Sub Inspector of Special Protection Force)	5%
	Note: The direct recruitment procedure and fixation of inter-se-seniority among such directly recruited candidates shall be same as specified in respect of "Stipendiary Cadet Trainee Reserve Sub Inspectors of Police (APSP)" prescribed in AP Police (Stipendiary Cadet Trainee) Rules, 1999 issued in G.O.Ms.No.315, Home (Police-C) Department, dated 13.10.1999 and as amended from time to time." Note 2: Meritorious Sports personnel shall have the same definition under G.O.Ms.No.56, G.A.(Ser.D) Department, dated 15.05.2026, and shall be determined in accordance with the definition prescribed by the Government from time to time.
