ORDER:

In the G.O first read above, Government have issued orders approving the name of the principals of Government Degree Colleges fit for promotion to the post of Regional Joint Directors of Collegiate Education for the panel year 2025-26 as recommended by the Screening Committee. Subsequently, Government have also issued orders for promotion and posting orders to certain officers in the reference second read above.

2. In the circumstances reported by the Commissioner of Higher Education, Andhra Pradesh, in the reference 3rd read above, and in exercise of the powers conferred under Rule 38 of the Andhra Pradesh State and Subordinate Service Rules, 1996, Government, hereby promote Dr. Illa Ravi, Principal, Government Degree College, Vinukonda as Regional Joint Director of Collegiate Education. On promotion, the individual is posted as Regional Joint Director of Collegiate Education, Guntur in the existing vacancy.

3. The above Principal of Government Degree College promoted as Regional Joint Director purely on temporary basis and should join in the post within a period of 15 days from the date of receipt of these orders as required under Sub Rule (b) of Rule 11 of the Andhra Pradesh State and Subordinate Service Rules, 1996 and if he fails to join the promotional post within the stipulated time or evade to join the post by proceeding on leave, he shall lose his promotion right/ offer for the current panel Year.

4. The above promotion is liable to be reverted to the lower post at any time without assigning any reason thereof, subject to directions / outcome of O.As/W.Ps/Was/RPs/CAs etc. if any, pending before the Tribunal / Courts etc.

5. The Commissioner of Higher Education, A.P., Mangalagiri shall take further action in the matter accordingly.
