ORDER :

Whereas, as per the records of this office, the date of birth of Sri.P.Pradeep Kumar, Joint Director of Town Planning/City Planner, Kurnool Municipal Corporation working on OD basis at O/o DTCP, AP, Amaravati is 30-08-1964 and accordingly, he has to retire from service on the A.N.of 31-08-2026 on attaining the age of superannuation of (62) years in terms of GO read (9) above.

And whereas, a Retirement Notice has already been issued to him vide G.O. read (11) above by the Government, as required under rules.

Now, therefore, in the light of above Government Orders and in exercise of the powers conferred on the Director of Town and Country Planning, Amaravati and in pursuance of the orders of the Government issued from time to time in respect of retirements of the Government employees on attaining the age of superannuation vide G.Os read (1) to (7) and (9 &11) above, following orders are issued:

Sri.P.Pradeep Kumar, Joint Director of Town Planning/City Planner, Kurnool Municipal Corporation working on OD basis at O/o DTCP, AP, Amaravati who is a member of A.P. Town Planning Service Rules is permitted to retire from service on the afternoon of 31-08-2026 on attaining the age of superannuation of (62) years, as per the existing Government orders, in force, issued in G.O.read (9) above.

He is informed that as per records of this office, he is facing disciplinary case as mentioned in the references cited (8) and hence he is not entitled to draw the Pensionary benefits like D.C.R.G. and commutation and other terminal benefits etc. till the finalization of disciplinary proceedings pending against him under Article 351-A of Pension Code, Rule.9 of A.P. Revised Pension Rules, 1980 even after retirement. However he is eligible for Provisional Pension only as per norms.

Further, he is allowed to retire from service subject to condition, that, if any other disciplinary proceedings that may arise prior to his retirement and without prejudice to the right of the Government / Department, will continue to be the disciplinary proceedings or judicial proceedings, during his service or after retirement, in terms of G.O.Ms.No.171, Finance & Planning Department,dt.01-07-1974 read with F.R 56 (10) (2).

Sri.P.Pradeep Kumar, Joint Director of Town Planning/City Planner, Kurnool Municipal Corporation, working on OD basis at O/o.DTCP, AP,Amaravati is hereby relieved from his duties on the afternoon of **31-08-2026**.

The Commissioner, Kurnool Municipal Corporation shall take necessary action accordingly.
