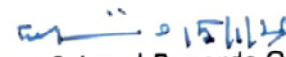
ANNEXURE-I

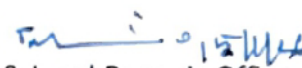

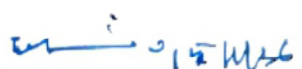
