EXEMPTION OF STAMP DUTY UNDER SECTION 9(1)(a) OF THE INDIAN STAMP ACT, 1899 AND REGISTRATION FEE UNDER SECTION 78 OF THE REGISTRATION ACT, 1908 FOR THE PROJECT OF BHABHA ATOMIC RESEARCH CENTRE (BARC), DEPARTMENT OF ATOMIC ENERGY, GOVERNMENT OF INDIA, IN RESPECT OF THE REGISTRATION OF SALE DEEDS, RELATING TO Ac.1947.225 CENTS OF LAND SITUATED IN ATCHUTHAPURAM AND MUNAGAPAKA MANDALS OF ANAKAPALLI DISTRICT INITIALLY AND SUBSEQUENTLY, FOR REMAINING LANDS UNDER THE BARC PROJECT (IN TOTO - 4,950ACRES).

NOTIFICATION-I

In exercise of the powers conferred by clause (a) of Sub Section (1) of Section 9 of the Indian Stamp Act 1899, the Governor of Andhra Pradesh hereby remit the Exemption of Stamp Duty and Registration Fees for the project of Bhabha Atomic Research Centre(BARC), Department of Atomic Energy (DAE), Government of India (Gol), from payment of Stamp Duty and Registration Fees in respect of the registration of Sale Deeds, initially, relating to Ac.1947.225 cents of land situated in Atchuthapuram and Munagapaka Mandals of Anakapalli District initially and subsequently, for remaining lands under the BARC project (in toto -4,950acres).

NOTIFICATION-II

In exercise of the powers conferred by Section 78 of the Registration Act, 1908 (Act XVI of 1908), the Governor of Andhra Pradesh hereby makes the following amendment to the Book 1 of CARD of "Table of fee" issued in G.O.Ms.No.463, Revenue (Regn.I) Department, dated:17.08.2013 and subsequently amended from time to time.

AMENDMENT

In the said "Table of Fees" after category 6(b)(vii), the following shall be added as 6(b)(viii)) namely:

6(b)(viii): No registration fee shall be levied for the project of Bhabha Atomic Research Centre(BARC), Department of Atomic Energy (DAE), Government of India (Gol), from payment of Stamp Duty and Registration Fees in respect of the registration of Sale Deeds, initially, relating to Ac.1947.225 cents of land situated in Atchuthapuram and Munagapaka Mandals of Anakapalli District initially and subsequently, for remaining lands under the BARC project (in toto - 4,950acres).
