NOTIFICATION-I

In exercise of the powers conferred by clause (a) of Sub section (1) of Section 9 of the Indian Stamp Act 1899, the Governor of Andhra Pradesh hereby remit the Exemption of Stamp Duty and Registration charges in respect of M/s. G.V. Estates & Hotels Pvt. Ltd., for development of 5-Star Hotel and Convention Centre for Relocation/revised land allotment of Ac.4.00 cents in Sy.Nos.172(P), 174(P), 193(P), 194(P) & 199(P) of Mandadam Village, Thulluru Mandal, Guntur District on the Agreement of Sale with Possession to be executed by APCRDA.

In exercise of the powers conferred by Section 78 of the Registration Act, 1908 (Act XVI of 1908), the Governor of Andhra Pradesh hereby makes the following amendment to the Book 1 of CARD of "Table of fee" issued in G.O.Ms.No.463, Revenue (Regn.I) Department, dated:17.08.2013 and subsequently amended from time to time.

AMENDMENT

In the said "Table of Fees" after category 6(b)(viii), the following shall be added as 6(b)(ix)) namely:

6(b)(ix): No registration fee shall be levied on documents value in respect of M/s. G.V. Estates & Hotels Pvt. Ltd., for development of 5-Star Hotel and Convention Centre for Relocation/revised land allotment of Ac.4.00 cents in Sy.Nos.172(P), 174(P), 193(P), 194(P) & 199(P) of Mandadam Village, Thulluru Mandal, Guntur District on the Agreement of Sale with Possession to be executed by APCRDA.
