ANDHRA PRADESH EXCISE (GRANT OF LICENCE OF SELLING BY SHOP AND CONDITIONS OF LICENCE) RULES, 2024 - RENEWAL RETAIL EXCISE TAX IN RESPECT OF SHOPS FOR THE LICENSE PERIOD 2026-27 (01.10.2026 TO 30.09.2027).

NOTIFICATION

In exercise of the powers conferred under Section 22 (e) of AP Excise Act 1968 read with sub-rule (1) of Rule 19-A of the Andhra Pradesh Excise (Grant of license of selling by Shop and conditions of License) Rules, 2024, the Government hereby notify the following Renewal Retail Excise Tax towards renewal of the Shop licence in Form A-4 for the period from 01.10.2026 to 30.09.2027 as indicated in the annexure of this order.

- (1) The Renewal Retail Excise Tax for the Shops for the license period from 01.10.2026 to 30.09.2027 shall be levied at the rate of 38% (percent) of the applicable annual Retail Excise Tax for the Shops for the Excise year 2025-26.
- (2) The Shops for the license period 2026-27 (01.10.2026 to 30.09.2027) shall be levied Renewal Retail Excise Tax at the rates indicated in the Annexure.
