ENDOWMENT SUBORDINATE SERVICE (NON-GAZETTED) RULES, 2002 -
CERTAIN AMENDMENTS.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with Andhra Pradesh Public Employment (Organisation of Local cadres and Regulation of Direct Recruitment) Order, 2025 and of all other powers hereunto enabling under sub-section (1) of section 153 of the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Act, 1987 (Act No.30 of 1987), the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowment Subordinate Service (Non-Gazetted) Rules, 2002, as subsequently amended from time to time.

The Notification shall be deemed to have come into force with effect on and from 15.07.2026.

AMENDMENTS

In the said Rules:

- (1) In Rule-2 under Class-II, after category (10), the following shall be added namely:
"category (11) Technical Assistant".
- (2) In Rule-3, under Class-II in the Table, after category (10) the following shall be added in column (1) and column (2) namely:

(11) Technical Assistant"

"(i) by Direct Recruitment".

- (3) In Rule-5, under Annexure in Class-II, after category 10 the following shall be inserted namely:

Class	Category	Method of Appointment	Qualification

II	Technical Assistant	by Direct Recruitment	Must possess a Diploma in Civil, Mechanical Engineering awarded by the Andhra Pradesh State Board of Technical Education or its equivalent qualification recognized by the State Government.

- (4) For Rule-7, the following shall be substituted, namely:

"7. Minimum Service for Promotion / Appointment by Transfer: No member of the service shall be eligible for appointment by transfer from the cadres of institutions published u/s 6 (a) or (b) or (c) or (d) of the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowment Act, 1987 or by promotion from a lower category, class, or grade to the next higher category, class, or grade unless he/she has put in not less than two (2) years of service in such lower category, class, or grade."

- (5) In Rule-12, for the existing Table thereunder, the following shall be substituted namely;

Note 1: The Unit of Appointment specified in Column (3) of the Table above shall constitute a separate unit for the purposes of appointment, recruitment, discharge, seniority, promotion, transfer and other service matters in terms of Paragraph 5(1) of the Presidential Order, 2025.

Note 2: The extent of reservation in favour of local candidates in direct recruitment to the categories of posts to be filled by direct recruitment shall be ninety-five percent (95%), as specified in the Presidential Order, 2025.
