AMENDMENTS TO THE ANDHRA PRADESH JAILS SUBORDINATE SERVICE
RULES, 1993.

[G.O.Ms.No.183, Home (Prisons & Fire), 21st September, 2026.]

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Jails Subordinate Service Rules, 1993, issued in G.O.Ms.No.514, Home (Prisons.A) Department, dated 23-11-1993, as subsequently amended from time to time.

The Notification shall be deemed to have come into force with effect on and from 24-08-2026.

AMENDMENTS

In the said Rules,

Note 1: The Unit of Appointment specified in Column (2) of the table above shall constitute a separate unit for the purposes of appointment, recruitment, discharge, seniority, promotion, transfer and other service matters in terms of Paragraph 5(1) of the Presidential Order, 2025.

Note 2: The extent of reservation in favour of local candidates in direct recruitment to the categories of posts to be filled by direct recruitment shall be ninety-five percent (95%), as specified in the Presidential Order, 2025."

3. Rule 11 along with table shall be omitted.

4. In Rule 12, under Sub Rules (a) and (b), for the districts mentioned in Note, the following shall be substituted, namely,-

"Srikakulam, Vizianagaram, Parvathipuram Manyam, Visakhapatnam, Anakapalli, Alluri Sita Rama raju, East Godavari, Kakinda, Dr. B.R.Ambedkar Konaseema, West Godavari and Eluru".

5. In Rule 12(A), for Sub Rule 1(iv), 2(iv), 3(iv) and 4(iv) the following shall be substituted, namely,-

"Selection : The final selection of the Candidates will be made strictly on relative merit, as obtained by them based on their score in the final written examination for 400 marks (Papers III and IV)."

6. for Rule 13, the following shall be substituted, namely:

"13. Transfers, Postings and Promotions:-

(1)The competent authority for effecting transfers, Postings and promotions of persons appointed to all categories of posts specified in the table under Rule (3) except Category 1(a) and 1(b) under Class A, within the respective Unit of appointment specified in column (2), shall be the concerned Deputy Inspector General of Prisons.

(2) The competent authority for effecting transfers, Postings and promotions of persons appointed to the posts falling under Category 1(a) and 1(b) under Class A in the table under Rule (3), within the respective Unit of appointment specified in column (2), shall be the Head of the Department i.e., Director General of Prisons & Correctional Services.
