SPECIAL RULES - ANDHRA PRADESH POLICE (CIVIL POLICE) SUBORDINATE
SERVICE RULES - CERTAIN AMENDMENTS.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh hereby makes the following amendments to the Special Rules for Andhra Pradesh Police (Civil Police) Subordinate Service Rules, issued in G.O.Ms.No.374, Home (Police.C) Dept., Dated.14.12.1999, as subsequently amended from time to time.

The Notification shall be deemed to have come into force with effect on and from 15.07.2026.

AMENDMENTS

In the said Rules, -

1. In Rule 12,

(i) for the existing Table, the following Table shall be substituted namely:

1	Class-A, Category-1, Sub Inspector of Police (Civil)	Zone-I comprising Srikakulam, Vizianagaram, Parvathipuram Manyam and Anakapalli districts and Commissionerate of Visakhapatnam City Zone-II comprising Alluri Sitarama Raju, East Godavari, Kakinada and Dr.B.R. Ambedkar Konaseema districts Zone-III comprising West Godavari, Eluru, Krishna districts and Commissionerate, NTR, Vijayawada City Zone-IV comprising Guntur, Palnadu, Bapatla, Prakasam and Sri Potti Sriramulu Nellore districts Zone-V comprising Tirupati, Chittoor, Annamayya and YSR Kadapa districts Zone-VI comprising Nandyal, Ananthapuramu, Kurnool and Sri Sathya Sai districts.
2	Class-A, Category-2, Assistant Sub Inspector of Police (Civil)	District/Commissionerate
3	Class-A, Category-3, Head Constable (Civil)	District/Commissionerate
4	Class-A, Category-4, Police Constable (Civil)	District/Commissionerate

(ii) In first proviso under the table, for the expression of Andhra Pradesh Public Employment (Organization of Local cadres and Regulation of Direct Recruitment) Order, 1975, "the expression Andhra Pradesh Public Employment (Organization of Local cadres and Regulation of Direct Recruitment) Order, 2025" shall be substituted.

(iii) After second proviso under the table, the following shall be added, namely;

"Note 1: The Unit of Appointment specified in Column (3) of the Table above shall constitute a separate unit for the purposes of appointment, recruitment, discharge, seniority, promotion, transfer, and other service matters in terms of Paragraph 5(1) of the Presidential Order, 2025.

Note 2: The extent of reservation in favour of local candidates in direct recruitment to the categories of posts to be filled by direct recruitment shall be ninety-five percent (95%), as specified in the Presidential Order, 2025."
