In the G.O. 1<sup>st</sup> read above, an amount of Rs. 5.00 Lakhs has been sanctioned to Smt.V. Laxmi, Office Subordinate, Industries and Commerce Department towards House Building Advance for site-cum-construction of a house in at Plot No.72, Survey No.192,193,194/A & 214 situated at Aipoor Village, Chityal Mandal, Nalgonda District and released a sum of Rs.1.25 lakhs towards 1<sup>st</sup> instalment.

2. In the reference 2<sup>nd</sup> read above, Smt.V. Laxmi, Office Subordinate, Industries and Commerce Department has requested Government to ratify the action of purchasing plot No.72 instead of Plot No.46 in the Survey No.192,193,194/A & 214 situated at Aipoor Village, Chityal Mandal, Nalgonda District was considered and ratified vide reference 3<sup>rd</sup> read above.

3. In terms of the orders issued in G.O. 5<sup>th</sup> read above, since the individual has submitted the sale Deed showing purchase of land for which 1<sup>st</sup> instalment is released and mortgage of land in favour of Government, the individual is eligible for release of 2<sup>nd</sup> instalment of Rs.2.50 lakhs. Government hereby release an amount of Rs.2.50 lakhs (Rupees two lakh fifty thousand only) to Smt.V.Laxmi, Office Subordinate, Industries and Commerce Department towards 2<sup>nd</sup> instalment subject to conditions stipulated in the G.O.1<sup>st</sup> read above.

4. The amount sanctioned in para 3 above shall be debited to the Head of Account :7610-Loans to Government Servants – MH 201 – House Building Advance – SH (05) Loans to Other Officers (non-plan) and met from the funds allotted to Industries and Commerce Department in the reference 3<sup>rd</sup> read above.

5. This order does not require the concurrence of Finance (A&L) Department as per rules in force.
