જે પૈકી ૦૧ ઉમેદવાર ફરજ પર હાજર ન થતાં, વિભાગના વંચાણે લીધા ક્રમ-૨ પરના ઠરાવથી હાજર ન થનાર ઉમેદવારશ્રી એન.આર.પટેલની નિમણૂક રદ કરવામાં આવેલ. ત્યારબાદ સામાન્ય વહિવટ વિભાગના વંચાણે લીધા ક્રમ-૩ પરના ઠરાવને ધ્યાને લઈ, જાહેરાત ક્ર.:૨૩/૨૦૨૦-૨૧ના પરીણામના આધારે તૈયાર કરેલ પ્રતિજ્ઞાયાદીમાંથી આર્થિક રીતે નબળા વર્ગના કુલ-૦૧ ઉમેદવારના નામની ભલામણ ગુજરાત જાહેર સેવા આયોગ દ્વારા કરવામાં આવેલ.

૧૪. મહાનિર્દેશકશ્રી, સરદાર પટેલ રાજ્ય લોક પ્રશાસન સંસ્થા (SPIPA), અમદાવાદની કચેરીએ તાલીમાર્થીઓની તાલીમ પૂર્ણ થયે, સરદાર પટેલ રાજ્ય લોક પ્રશાસન સંસ્થા ખાતેનો સંસ્થાકીય તાલીમ અંગેનો અહેવાલ તેમજ તાલીમાન્ત પરીક્ષાના પરિણામની નકલ આ વિભાગને મોકલવાની રહેશે.
૧૫. અજમાયશી સમય દરમ્યાન આ અજમાયશી અધિકારીઓ મહાનિર્દેશકશ્રી, સરદાર પટેલ રાજ્ય લોક પ્રશાસન સંસ્થા, અમદાવાદના નિયંત્રણ હેઠળ રહેશે. ક્ષેત્રીય તાલીમ દરમ્યાન તેઓએ જે તે જિલ્લાના કાર્યમથકે નિવાસ કરવો ફરજિયાત રહેશે અને તે અંગે સંબંધિત અધિકારીશ્રીએ પુરતી તકેદારી રાખવાની રહેશે અને જો કોઈ અજમાયશી મદદનીશ નિયામક, બોઈલરો, વર્ગ-૨ની હાજરીમાં અનિયમિતતા જણાય તો સત્વરે શ્રમ આયુક્તશ્રીએ શ્રમ, કૌશલ્ય વિકાસ અને રોજગાર વિભાગને રીપોર્ટ આપવાનો રહેશે. શ્રમ, કૌશલ્ય વિકાસ અને રોજગાર વિભાગ સંબંધિતની આવી ગેરહાજરીને ગંભીર ગેરશિસ્ત ગણીને નિયમોનુસાર કાર્યવાહી કરશે.
૧૬. ગુજરાત મુલ્કી સેવા વર્ગ-૨ (મદદનીશ નિયામક, બોઈલરો, વર્ગ-૨ સંવર્ગ)નું કાર્યક્ષેત્ર સમગ્ર ગુજરાત રાજ્ય હોય રાજ્ય સરકાર અજમાયશી સમય દરમ્યાન તથા લાંબાગાળાની નિમણૂક બાદ તેઓની કોઈપણ સ્થળે નિમણૂક તથા બદલી કરી શકશે.
૧૭. શ્રમ આયુક્તની કચેરીએ ઉમેદવારની સેવાપોથી તૈયાર કરાવડાવી તેના પહેલા પાનાની પ્રમાણિત નકલ અત્રે મોકલી આપવાની રહેશે. જે ઉમેદવારો અજમાયશી મદદનીશ નિયામક, બોઈલરો, વર્ગ-૨ તરીકેની નિમણૂક પામે તે પહેલાં સરકારી/અર્ધ-સરકારી સેવામાં હોય તેમના કિસ્સામાં તેમની અગાઉની સેવાપોથી પ્રથમ પાનાની પ્રમાણિત નકલ અત્રે મોકલી આપવાની રહેશે. તેઓએ નાણાં વિભાગના તા.૨૮/૦૫/૨૦૦૪ના ઠરાવની જોગવાઈ મુજબ સરકારી સેવામાં દાખલ થયા તારીખથી છ માસની મુદતમાં સક્ષમ સત્તાધિકારી સમક્ષ વતનના સ્થળ અંગે નોંધણી કરાવવાની રહેશે. આ નોંધ કરાવવાના સમયે વતનના સ્થળે કર્મચારી/અધિકારી સ્થાવર મિલકત ધરાવતા હોય અથવા નોકરીમાં જોડાયા તે પૂર્વે રહેતા હોય તેના અધિકૃત પુરાવાની નકલ રજૂ કરવાની રહેશે અને તે સંબંધિત કર્મચારી / અધિકારીની સર્વિસબુકમાં ચોંટાડવાની રહેશે. પોતાની સર્વિસબુકમાં વતનના સ્થળની નોંધણી થઈ હોવા બાબતે કર્મચારી / અધિકારીએ જાતે ખાતરી કરી લેવાની રહેશે. સર્વિસબુકમાં નોંધણી કરવાની રહી જવા પામી હોવાની સ્થિતિમાં પ્રથમ નિમણૂક જે સ્થળે થઈ હશે તેને કર્મચારી / અધિકારીનું વતનનું સ્થળ ગણવાનું રહેશે. વતનના સ્થળ અથવા તેવા ફેરફાર અંગેની કોઈ રજૂઆતો વિચારણાને પાત્ર બનશે નહીં. વધુમાં કર્મચારી / અધિકારી પહેલેથી સરકારી / અર્ધ સરકારી સેવામાં હોય તેમના કિસ્સામાં તેઓએ નવેસરથી તેમના વતન અંગે એકરાર કરવાની જરૂર નથી. પરંતુ આ અંગે સેવાપોથીમાં થયેલ વતનની નોંધની પ્રમાણિત નકલ આ વિભાગને મોકલવાની રહેશે.
૧૮. અજમાયશી તરીકે હાજર થયા બાદ દિન-૩૦ માં સંબંધિત કચેરીએ તેઓનું HRMS / કર્મયોગી પોર્ટલ પર મેપીંગ કરાવી તેઓની રજાઓ તથા અન્ય બાબતો HRMS / કર્મયોગી પોર્ટલ ઉપર જ હાથ ધરવાની રહેશે.
૧૯. તેઓને ગુજરાત રાજ્ય સેવા (વર્તણૂક) નિયમો, ૧૯૭૧ની જોગવાઈ લાગુ પડશે.
