- (૧૮) કચેરી અધીક્ષક, વર્ગ-૨ની જગ્યા પર નિમણૂક માટે પસંદગી પામેલ અનામત વર્ગના ઉમેદવારોના જાતિ પ્રમાણપત્ર તથા અન્ય લાયકતો બાબતે ભવિષ્યમાં કોઈ વાંધાકારક હકીકત જણાશે તો પસંદગી પામેલ ઉમેદવારની નિમણૂક તાત્કાલિક અસરથી રદ કરવામાં આવશે.
