CONSTITUTION OF INDIA.

No.G/SH/21/2026/ED/out/e-file/3/2025/6025/GH:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Librarian, Class III, (Non-teaching) in the Government Polytechnic Recruitment Rules, 2015, namely: -

- (1) These rules may be called the Librarian, Class III, (Non-teaching) in the Government Polytechnic Recruitment (Amendment) Rules, 2026.
 - (2) They shall come into force on the date of their publication in the *Official Gazette*.
- In the Librarian, Class III, (Non-teaching) in the Government Polytechnic, Recruitment Rules, 2015 (hereinafter referred to as "the said rules"), in rule 2, in clause (a), for the words "by promotion of a person of proved merit and efficiency", the words "by promotion of a person who possesses "Good" benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967" shall be substituted.

3. In the said rules, in rule 4, -

- (1) in clause (a), for the words and figures "not be more than 32 years of age", the words and figures "not be more than 36 years of age" shall be substituted.
- (2) in clause (b), for sub-clause (i) the following sub-clause shall be substituted, namely: -
 "(i) a bachelor's degree in the Library and Information Science or Library Science obtained from any of the Universities or Institutions established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared as deemed to be a University under section 3 of the University Grants Commission Act, 1956;"
