No. GT/2026/6/IBD/MISCE/e-file/10/2026/0198/B:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules to repeal the Departmental Examination for the Class III Posts, (Administrative Wing) in the Commissionerate of Information, Rules, 2012 issued under the Government Notification, Information and Broadcasting Department No. GT/2012/12/INF/102005/2512/Part-I/B, dated the 30th Aug., 2012.

1. These rules may be called the Departmental Examination for the Class III Posts, (Administrative Wing) in the Commissionerate of Information, (Repeal) Rules, 2026.

2. The Departmental Examination for the Class III Posts, (Administrative Wing) in the Commissionerate of Information, Rules, 2012 are hereby repealed:

Provided that such repeal shall not affect anything done or any action taken under the rules, so repealed.

CONSTITUTION OF INDIA.

NO:- GR-2026-93-LED/RCR/e-file/11/2022/1346/R1-Section:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Administrative Officer/Assistant Planning Officer, Class II, in the Gujarat Skill Training Service, under the Directorate of Employment and Training, namely:-

1. (1) These rules may be called Administrative Officer/Assistant Planning Officer, Class II, under the Directorate of Employment and Training, Recruitment Rules, 2026.
(2) They shall come into force on the date of their publication in the *Official Gazette*.
2. Appointment to the post of Administrative Officer/Assistant Planning Officer, Class II, under the Directorate of Employment and Training, shall be made either, -
 - (a) by promotion of a person who possesses "Good" benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons, who, -
 - (i) have worked for not less than seven years in the cadre of Head Clerk, Class III, in the subordinate service under the Directorate of Employment and Training; and
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience as specified in sub-clause (i) above is not available for promotion and it is necessary in public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period as specified in sub-clause (i) above; or
 - (b) On the basis of the result of the competitive examination held for the purpose;
3. The appointments by promotion and on the basis of the result of the competitive examination held for the purpose shall be made in the ratio of 2:1.
4. To be eligible for appointment on the basis of the result of the competitive examination held for the purpose to the post mentioned in rule 2, the candidate shall, -
 - (a) not be more than 35 years of age;
 - (b) Possess a bachelor's degree obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognized as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognized by the Government;
 - (c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
 - (d) possess adequate knowledge of Gujarati or Hindi or both.

5. The candidate appointed on the basis of the result of the competitive examination held for the purpose shall be on probation for a period of two years.
6. The candidate appointed on the basis of the result of the competitive examination held for the purpose, during his probation period, shall be required to undergo pre-service training and pass the post-training examination in accordance with the provisions of the Gazetted Officer's (Pre-Service Training and Examination) Rules, 1970.
7. The candidate appointed on the basis of the result of the competitive examination held for the purpose, during his probation period, shall be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
8. The candidate appointed on the basis of the result of the competitive examination held for the purpose shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
9. The candidate appointed either on the basis of the result of the competitive examination held for the purpose or by promotion shall be required to undergo such training and pass such examination as may be prescribed by the Government.
10. The candidate appointed on the basis of the result of the competitive examination held for the purpose shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
