The theme for this year's International Women's Day, 'Give to Gain', beautifully reflects ESIC's core guiding principle of Niswarth Seva (selfless service). Shri Ashok Kumar Singh, Director General, ESIC, remarked that the theme is a powerful testament to the corporation's unwavering dedication to social security. He further emphasized that through its comprehensive healthcare initiatives, ESIC continues to empower women beneficiaries nationwide by ensuring consistent access to quality medical care and robust social protection. Currently, ESIC provides social security and healthcare services to over 3.84 crore insured persons and their families, maintaining a specialized focus on women's health, maternity benefits, and overall welfare. In her address, Ms. T. L. Yaden, Financial Commissioner, ESIC, said that ESIC remains committed to empowering women beneficiaries across the country and continuously supporting their health, security and welfare.



ESIC officials and staff took the "Purple Ribbon Pledge," an Ashray Trust initiative, committing to actively oppose the exploitation and abuse of women and girls. Led by Program Coordinator Munjesh Yadav, the ceremony emphasized collective community responsibility as the foundation for protecting the most vulnerable of the society.

As part of the festivities, guest speaker and Life Coach Ms. Anju Bahri encouraged women to value themselves and embrace change with confidence.
