

CGST Chhatrapati Sambhaji Nagar Celebrates 9th GST Day, Honours Taxpayers and Officers

The Central Goods and Services Tax (CGST) Commissionerate, Chhatrapati Sambhaji Nagar, celebrated the 9th GST Day on July 1 with a grand function at GST Bhawan, Chhatrapati Sambhaji Nagar under the theme “सुगम कर व्यवस्था, सुशक्त भारत” (Simple Tax System, Empowered India). The event recognised the contributions of taxpayers and departmental officers towards strengthening the Goods and Services Tax (GST) regime and promoting voluntary tax compliance.
