

Provisional Estimates of Wholesale Price Index (Base Year 2022-23) for the month of August 2026

Key highlights of WPI (Base Year 2022-23) for August 2026

- i. All India Wholesale Price Index (WPI) inflation for August 2026 is 9.92 per cent on year-on-year (YoY) basis, compared to 9.78 per cent in July 2026. The index for All Commodities for August 2026 stands at 110.8, whereas it was 110.0 in July 2026.
- ii. YoY inflation rates for major groups, namely, Primary Articles, Fuel and Power, and Manufactured Products are 7.76 per cent, 22.93 per cent, and 8.37 per cent, respectively in August 2026, compared to 8.52 per cent, 20.05 per cent, and 8.29 per cent, respectively in July 2026. The indices for Primary Articles, Fuel and Power, and Manufactured Products are 118.1, 108.3 and 108.8, respectively, in August 2026, whereas they were 117.2, 105.4, and 108.4, respectively, in July 2026.
- iii. Across groups, 'Mineral Oils (containing Petroleum Products)', 'Food Articles', 'Manufacture of Food Products', 'Manufacture of Basic Metals', 'Non-Food Articles', and 'Manufacture of Chemicals and Chemical Products' have been major drivers of WPI inflation in August 2026.
- iv. **WPI Food Index (weight=24.99 per cent):** The Food Index consists of 'Food Articles' from Primary Articles major group, and 'Manufacture of Food Products' from Manufactured Products major group. It observed a YoY inflation of 7.05 per cent in August 2026, compared to 6.65 per cent in July 2026.
- v. Monthly indices and Inflation Rate (in per cent) for All commodities and Major Groups, along with major group-wise contribution for the past months are presented in the charts below

Chart 1: WPI Index and Inflation Rate for All Commodities

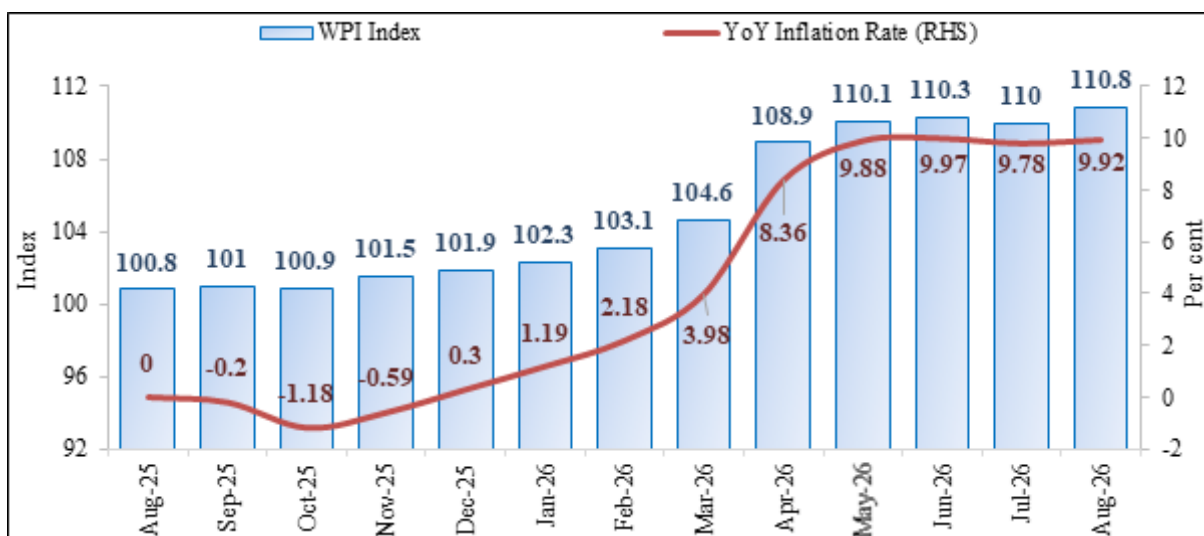


Chart 2: WPI Index of Major Groups

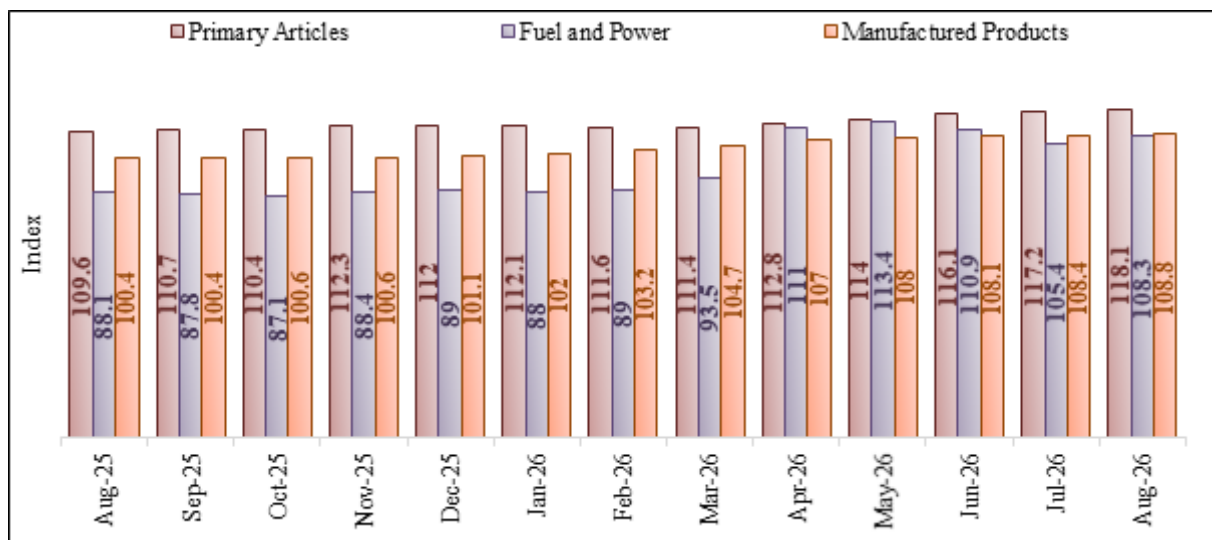


Chart 3: Inflation Rate across Major Groups

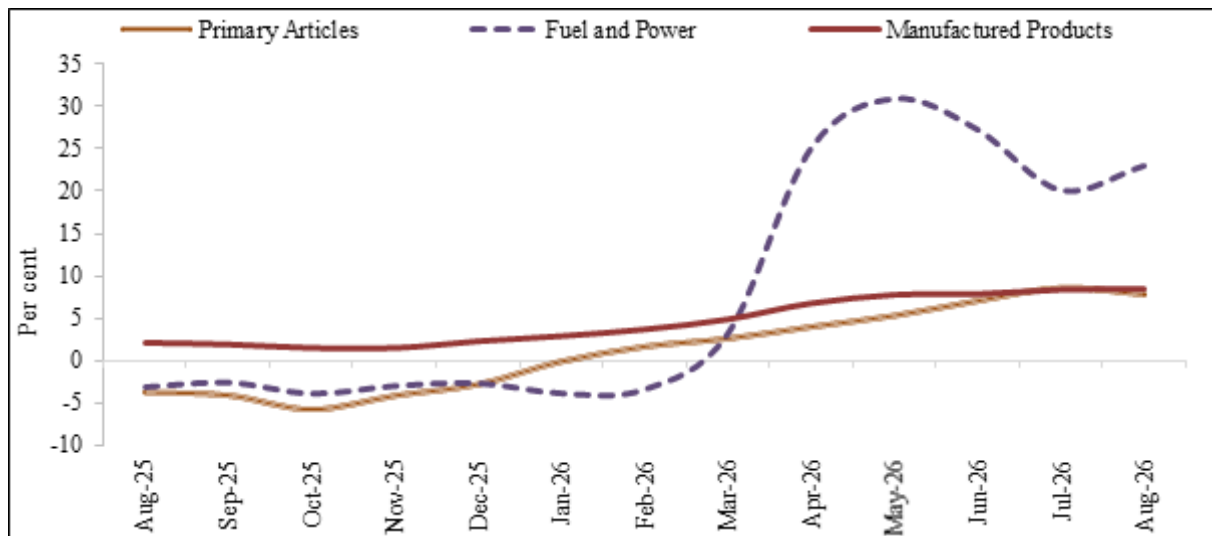
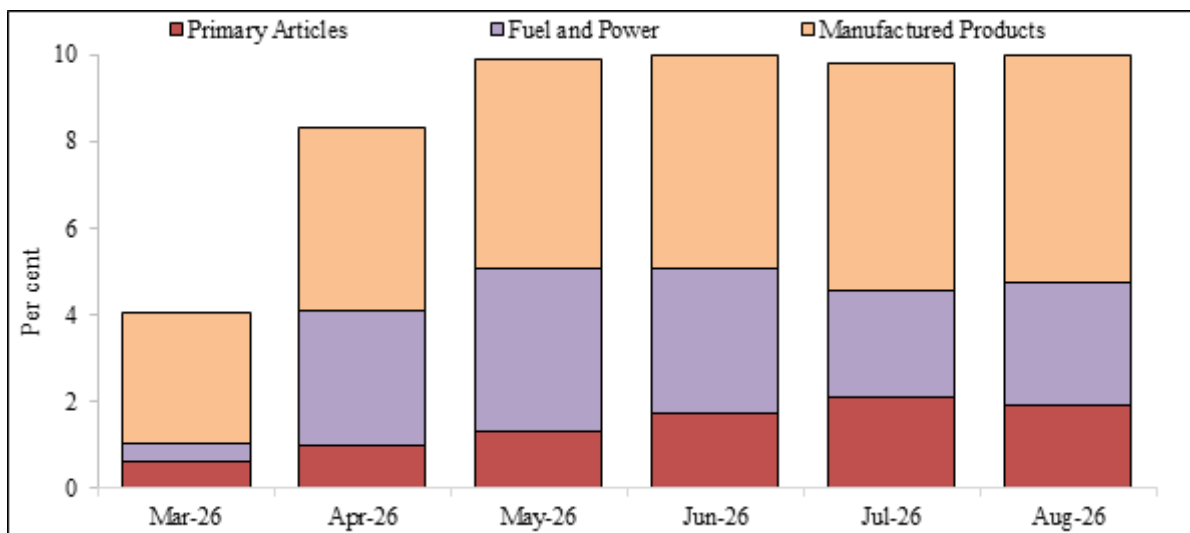


Chart 4: Major Group-Wise contribution to Inflation



1. The **final index for the month of June 2026** has been revised from 110.2 (Provisional estimate) to 110.3. Accordingly, WPI inflation has been revised from 9.87 per cent, as per provisional estimate to 9.97 per cent as per the final estimate.
2. The Final Estimate of WPI (Base Year 2022-23) for the month of June 2026 has been compiled with a weighted response rate of 99.3 per cent.
3. The Provisional Estimate of WPI (Base Year 2022-23) for the month of August 2026 has been compiled with a weighted response rate of 84.4 per cent.

4. Wholesale Price Index and Year-on-Year (YoY) Inflation Rate for All Commodities, Major Groups, and Groups for the last six months is given at **Annexure-I and II** respectively.
5. Cumulative WPI for All Commodities, Major Groups, and Groups from April to August for FY 2023-24, FY 2024-25, FY 2025-26, and FY 2026-27 is given at **Annexure-III**.

- i. All India Output PPI for All Commodities for August 2026 stands at 110.8, whereas it was 109.9 in July 2026.
- ii. Output PPIs for Agriculture, Forestry and Fishing; Mining and Quarrying; Manufactured Products; and Electricity are 116.5, 122.0, 109.7, and 90.9, respectively, in August 2026, whereas those were 115.6, 119.4, 108.8, and 92.4, respectively, in July 2026.

Chart 5: Output PPI for All Commodities

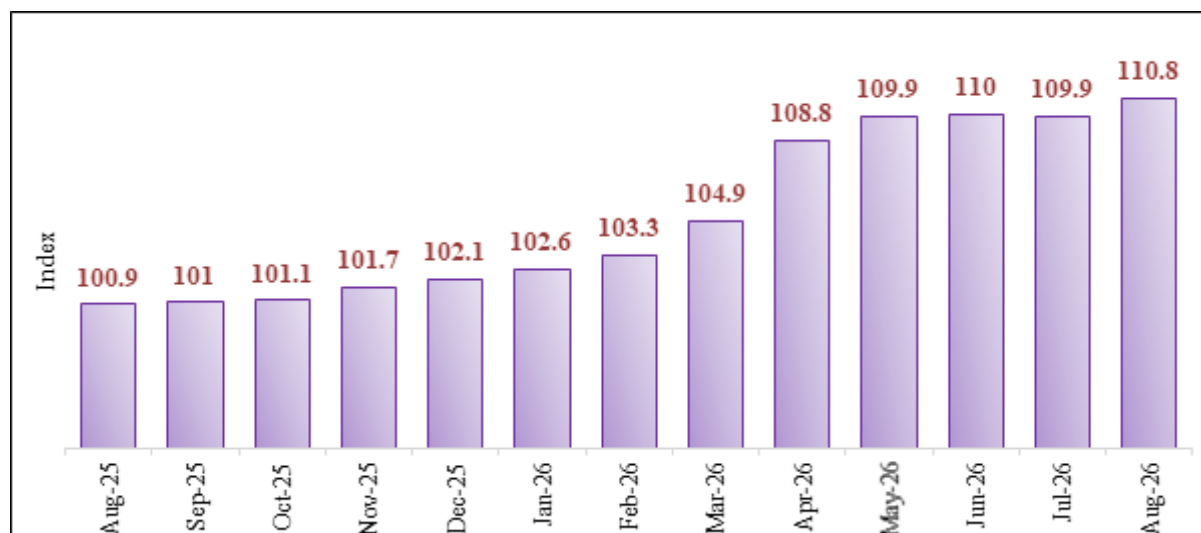
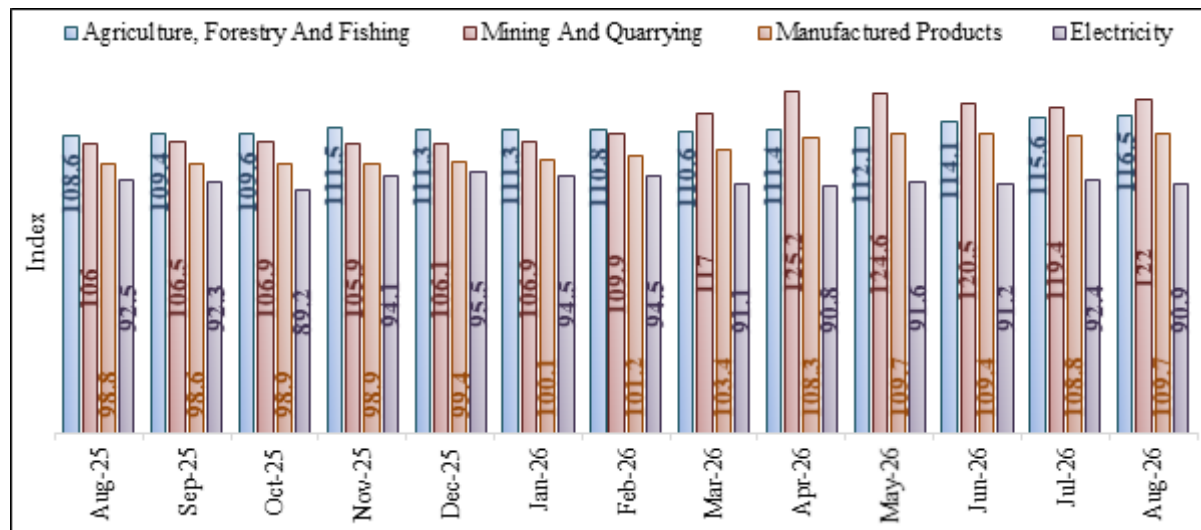


Chart 6: Output PPI across Major Groups
