



SAI to Conduct Selection Trials for Men's and Women's Wrestling in Mumbai on September 30

Mumbai, 24 September 2026

The Sports Authority of India (SAI), National Centre of Excellence (NCOE), Mumbai, under the Ministry of Youth Affairs & Sports, Government of India, will conduct selection trials for Men's and Women's Wrestling on September 30, 2026.

The trials will be held at the SAI Shri Atal Bihari Vajpayee National Centre of Excellence, Akurli Road, Kandivali (East), Mumbai.

The selection trials are open to eligible boys and girls in the Under-17, Under-20 and Under-23 age groups. The weight categories for the trials are as follows:

- Women's Wrestling: Girls – 50 kg and above
- Freestyle Wrestling: Boys – 57 kg and above
- Greco-Roman Wrestling: Boys – 55 kg to 130 kg

Athletes participating in the trials are required to report at the venue at 8:00 AM on September 30, 2026.

Eligible athletes should bring all necessary documents, certificates and other records in support of their age, identity and eligibility for the selection trials.

The trials will provide an opportunity for eligible young wrestlers to participate in the selection process for training at the SAI National Centre of Excellence, Mumbai.
