**The Air Navigation (Restriction of Flying) (Coventry)
Regulations 2026**

Made - - - -

30th June 2026

Coming into force - -

4th July 2026

The Secretary of State has decided that it is necessary in the public interest to restrict the flying of unmanned aircraft in the area specified in regulation 3(1) by reason of the intending gathering there of a large number of persons.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016^(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Coventry) Regulations 2026 and they come into force on 4th July 2026.

Interpretation

2. The times referred to in regulation 3(1) are Co-ordinated Universal Time^(b).

Restricted airspace

3.—(1) Subject to paragraph (2), during the period beginning with 1100 hours and ending with 2259 hours on each of the two days of 4th and 5th July 2026 no unmanned aircraft is to fly below 1,300 feet above mean sea level within the area bounded by the following points—

- (a) 522441N, 0013053W,
- (b) 522446N, 0013033W,
- (c) 522437N, 0013015W,
- (d) 522431N, 0013009W,
- (e) 522421N, 0013008W,
- (f) 522423N, 0013056W, and
- (g) 522441N, 0013053W.

(2) Paragraph (1) does not apply to any unmanned aircraft flying in accordance with a permission issued by the West Midlands Police Counter-UAS Team.

(b) Co-ordinated Universal Time (UTC) is one hour behind British Summer Time (BST).

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on the flying of unmanned aircraft in the vicinity of Coventry, West Midlands, where the gathering of a large number of persons is due to take place. The Civil Aviation Authority and the Department for Transport agree that it is necessary and in the public interest to restrict the flying of unmanned aircraft for reasons of public safety and security.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).

In relation to the permission mentioned in regulation 3(2), the West Midlands Police Counter-UAS Team may be contacted as notified.

Full details of this Statutory Instrument will be promulgated by Briefing Sheet and Notice to Aviation (NOTAM).
